### **Tallong Twitterings**



Recovery is the message behind the sculptures recently placed in the Nature Reserve Walkway in Tallong's Memorial Park. They depict representations of local wildlife; Kangaroo, Wombat, Echidna, Platypus, Lyrebird, Koala, Flying and Hanging Bat species as well as endangered species like the Glossy Black Cockatoo and the Midge Orchid and have been created by local custom sculptor Hoonart. Plantings of Allocasuarina littoralis, the main diet of the Glossy Black Cockatoo and the large scale sculpture of the Midge Orchid draw attention to the recovery of local habitats of endangered and other species after the drought and subsequent bushfires that destroyed bushland earlier this year. The local community draws significance from the tiny orchid (botanical name Corunastylis plumosum or formally Genoplesium plumosum) which only flowers in the Tallong district for several days in March and only after heavy rain, giving it the common name Tallong Midge Orchid. Tallong's shop /café called the Midge is a central meeting place for locals and tourists and like its namesake draws on this icon as a point of village identity.

An additional sculpture of a lifesize fireman is dedicated to all the RFS members who defended Tallong from the encroaching fires that threatened Tallong on two fronts branching off from the Morton National Park's Currowan fire when it crossed over the Shoalhaven Gorge. The Sculptures were funded by a NSW bushfire recovery grant given to Goulburn Mulwaree Council. By allocating these funds to Tallong it was intended to create a safe, peaceful place for community recovery as well as the development of an event in the park that gave local businesses like the Midge a chance to cater for it and thus stimulate local business recovery.

Tallong Public School principal, Ms Emily Morrow is delighted with the installation of the sculptures in the Nature Reserve. She said that as well as being nearby it is an interesting place for students to explore. The Nature Reserve is a great teaching tool for the students to learn about local species and their own environment. Awareness of environmental issues is a key part of the school curriculum and the significance of the Midge Orchid locally is a worthy research project. The community has participated in various environmental programs like the Glossies in the Mist campaign which saw community members anticipating future food sources for the Glossy Blacks by planting large numbers of casuarina trees. Ms Morrow is waiting for current Covid restrictions to be lifted for the whole school to be able to visit the Nature Reserve.

Throughout the history of Tallong Public School there has been an awareness of the local environment, preserving bushland and planting of trees at the annual Arbor Day ceremonies. At present this tree planting day is held in July but in 1896 Arbor Day was held in August. At that time the school sited on Hope Street and called Barbers Creek Public School is recorded in the Goulburn Evening Penny Post on the 13th August of that year ceremoniously planted fifty trees obtained from the Sydney Botanical Gardens and a local resident. Today some of the trees can be seen on the site, most notable the Camphor Laurel which students recalled in poems and compositions on display at the schools centenary exhibition. The ceremony started with each student, principal Miss Gwynne, parents, friends and visitors planting the trees then a picnic meal was served "a splendid repast provided by parents and friends" followed by a student concert. At the conclusion of the Day Miss Gwynne was cheered and reciprocated by thanking "those friends who assisted in making Arbor Day such a glorious success". The article's author claimed that "if all the trees grow Barbers Creek Public School grounds will be one of the beauty spots on the southern railway line".









VALE ALETA CURRY.

It was with great shock and sadness that Tallong residents learned of the death of Aleta Curry in Goulburn Hospital, on Wednesday morning 26 August 2020.

Aleta was the third President of the Tallong Community Focus Group after serving as Vice President while David Leese was in charge. She became President in October 2008, remaining in that position for 2 years. The committee she led was responsible for overseeing the development of a more proactive stance with regard to Goulburn Mulwaree Council than during preceding years, which has been built on subsequently. The TCFG was heavily involved in the development of the Tallong Village Plan of 2010, organising community involvement through a questionnaire and workshop meetings.

During this time also, the village regained control of the old picnic ground and playing field on Barbers Creek Rd. and by the middle of 2009 the Tallong Picnic and Recreation Reserve Trust had been gazetted. Aleta was a member of the Reserve Trust until 2019. The Paint the Pot project was completed in 2009 and the completed work was officially opened on Apple Day, 2009. As President of the TCFG, Aleta was also head of the organising committee for Apple Day for two years as well as being an ex-officio (non-voting) member of the Tallong Memorial Hall Trust.

With her history degree and interest in oral history, Aleta was involved in the writing of the book "Tallong: a Heritage". She covered the twentieth century history of the village as well as formatting the final document.

Aleta was a forceful and dynamic woman who carried herself with grace and dignity. She had definite opinions but believed strongly that, as she wrote in her President's Report of 2010: "Cooperation needs to remain a watchword; when community groups become more concerned about individual areas of control rather than the district as a whole, people may be able to satisfy their egos with a sense of power and control in the short term, but eventually the region will decay due to a lack of real commitment and support." She also had a wicked sense of humour and will be greatly missed by everyone who came in contact with her.

## Bush Fire Danger Period and Fire Permits

A Fire Permit is required for burning activities during the Bush Fire Danger Period. Fire Permits help ensure fire is used safely and minimize the danger to you, your property and the community.

# The key things to remember

- You need a fire permit if it's the Bush Fire Danger Period.
- Just because it's the Bush Fire Danger Period doesn't mean you can't use fire - but there are restrictions to ensure fire is used safely.
- Getting a permit is free and easy. Contact your local <u>Fire Control</u> <u>Centre</u>.
- There are heavy penalties if you don't follow restrictions or rules.

Please note that other restrictions, approvals and/or permits may apply to council areas where the Bush Fire Danger Period has not been declared. For example, backyard burning is not permitted in many suburban areas due to Environmental Regulations and Council or Environmental Protection Authority (EPA) permission is required.

# What is a Fire Permit?

Fire Permits help ensure fire is used safely during the Bush Fire Danger Period. A permit imposes conditions on the way a fire is lit and maintained, and can only be issued by authorised Permit Issuing Officers.

The permit system ensures agencies like the NSW RFS know when and where landholders intend to burn, to ensure adequate and appropriate measures are in place, and so that fires remain under control.

To carry out a Bush Fire Hazard Reduction Burn, you may need:

• a Fire Permit and/or

 an Environmental Approval such as a Bush Fire Hazard Reduction Certificate. You must gain this before applying for a Fire Permit.

The Permit Issuing Officer may add any conditions deemed as necessary but all permits have standard conditions that, such as:

- the permit is to be carried by the permit holder, on site, at the time the fire is lit
- the permit is to remain on site with those present until extinguished, if applicable
- the fire must be supervised at all times unless the permit says otherwise
- notifications are given to the NSW RFS, and adjoining neighbours at least 24 hours (unless specified otherwise) prior to the fire being lit and
- the permit may be varied, cancelled or suspended, depending on weather conditions.

# When are permits required?

The statutory Bush Fire Danger Period runs from 1 October to 31 March;however it may vary due to local conditions. If you are planning to light a fire in the open during this time, you will need a Fire Permit.

You can find out if permits are required in your area below.

Also depending on the type of fire, a permit may be required all year round. For example, a Fire Permit is required at all times if a fire is likely to be dangerous to a building.

# When are permits not required?

Fire Permits are not required for fires that are lit for the purpose of land clearance or the creation of a fire break during the Non-Bush Fire Danger Period.

Additionally, Fire Permits are not required for fires for the purpose of cooking food, provided that:

- the fire is in a permanently constructed fireplace;
- at a site surrounded by ground that is cleared of all combustible materials for a distance of at least two meters all around;
- the fire is completely extinguished before leaving.

# What else do I need to do?

Before lighting the fire ensure that:

- it can be contained and controlled within the specified area
- it does not contain toxic materials, such as rubber tyres, plastics, paint etc; and
- it must not cause an air pollution problem by producing excessive amounts of smoke.

If you have a permit, it is your responsibility to:

- check whether a Total Fire Ban in force on our <u>Fire Danger Ratings and</u> <u>Total Fire Ban page</u>. If there is, your permit is automatically suspended.
- check whether a No Burn day has been declared on the <u>EPA</u> <u>website</u>
- check the expected weather conditions
- notify and check with your local NSW RFS
  Fire Control Centre or
  Fire and Rescue NSW
  station prior to lighting.
- follow any conditions restrictions listed in your permit.

# Applying for a permit

If in doubt about whether you require a Fire Permit, or to apply for one, contact your local NSW RFS Fire Control Centre or Fire and Rescue NSW station.

### **Fines and penalties**

Substantial fines and prison terms of up to 12 months may apply to persons found to be in breach of the Rural Fires Act 1997 and its Regulations.

Civil lawsuits can also be brought against persons responsible for fire, by those seeking compensation, for losses sustained.

### ASSESSING YOUR FIRE RISK How Well Prepared Should You Be?

Preparing your property before or early in the fire season increases its resilience in the face of a fire event this season. Assessing your property's risk is a good way to consider what things you should prioritise whilst preparing your home or business. Some things to look for while assessing your property include:

- Are you close to bushland with high fuel loads?
- Do you live in a designated bushfire

prone area (such as much of Tallong)?

- Are you situated on a slope or ridgeline? – Fire runs quicker uphill.
- Do you have tracts of vegetation on or running to your property?
- Do you have combustible materials near structures such as bushes/shrubs, woodpiles, building materials, waste piles or leaf litter in gutters?
- Do you have limited or hazardous access to your property – can a fire truck reach you with ease?

 Do you have enough water for firefighting or are distant from firefighting services?

If you answered yes to some of these, then you need to prepare your property NOW! The RFS website (www.rfs.nsw.gov.au) and the Tallong RFB have fact sheets, checklists and other publications available, so jump online or drop into the station and be as prepared as you can be!

### VOLUNTEERING AND TRAINING WITH THE RFS New Members and Enquiries are Always Welcome
